Mahindra Auto registers 8% growth in Utility Vehicles segment in June 2019

- Mahindra's Passenger Vehicles segment grows 4% in June 2019
- Growth led by its 3 recent product launches, in an otherwise slow market

Mumbai, July 1, 2019: Mahindra & Mahindra Ltd. (M&M Ltd.), a part of the USD 20.7 billion Mahindra Group, today announced its auto sales performance for June 2019. M&M sold **17,723** Utility Vehicles in June 2019, a growth of **8%** over June 2018.

The Passenger Vehicles (PV) segment (which includes UVs, Cars and Vans) sold **18,826** vehicles in June 2019, as against **18,137** vehicles during the same period last year, a growth of **4%**.

In the Commercial Vehicles segment, the company sold **16,394** vehicles in June 2019, as against **19,229** vehicles in June 2018.

In the Medium and Heavy Commercial Vehicles segment, M&M sold **705** vehicles for the month. Exports for June 2019 stood at **3,076** vehicles.
