Mahindra's Auto Sector sells 51,896 vehicles during October 2019

Mumbai, November 1, 2019: Mahindra & Mahindra Ltd. (M&M Ltd.), a part of the USD 20.7 billion Mahindra Group, today announced its auto sales performance for October 2019.

In the Passenger Vehicles segment (which includes UVs, Cars and Vans), Mahindra sold **18,460** vehicles in October 2019, compared to **24,066** vehicles in October 2018.

In the Commercial Vehicles segment, the company sold **23,582** vehicles in October 2019, as against **24,353** vehicles in October 2018.

In the Medium and Heavy Commercial Vehicles segment, Mahindra sold **402** vehicles for the month. Exports for October 2019 stood at **2,703** vehicles.

Mahindra's Farm Equipment Sector Sells 44,646 Units in India during October 2019
